## Payment and Settlement Terms

- Payment and Settlement Terms
  Customers who wish to open credit facilities shall complete the credit application pack quoting the credit limit required and the names and addresses of two current commercial references and one bankers reference.

  BED retains the right to decline any applications for credit facilities without giving any reason.

  Credit accounts are subject to settlement within one calendar month following the month in which invoices were raised

  Where a credit customer is in default in the payment of any account, then all souns owned to BED by the customer on any account whatsoever, become immediately due and payable in full.

  If the customer has no credit account BED will accept payment from the customer by cash, cheque, bankers draft or credit/debit card.

  Where a cheepus is offered by the customer in payment for goods BED reserves the right to delay the despired of the goods pending the clearance of that cheque,

  BED reserves the right to charge interest on any overdue amounts at the rate of 8% over NatWest Bank pic base rate.

- Retention of Title

  The customer acknowledges that before an agreement fee the puechase of any goods from BED he has expressly represented and warranted that he is not insolvent and has not committed any act of bankruptcy, or being a company with limited or unlimited liability, knows of no circumstances which would entitle any debenture holder or secured creditor to appoint a receiver, or liquidation, to perfule the company's over or against the company's assets.   necessarily mean that BED will accept liability in relation to such a claim. A delivery note signed "unexamined" is not sufficient to
  uphold a claim.

  If there is any discrepancy between goods advised as returned and the actual goods received, BED will only credit the items returned.

  Bows, cases and pallets that have been charged by BED will be credited in full when returned to BEDs dispatching depot in good condition, carriage paid, within fourteen days of the date of BEDs invoice. Drums will be charged according to manufacturers schedules.
